NJ'S STUDENT RIGHTS AND VOICE IN AFTERMATH OF PARKLAND

Remarks on student civic engagement delivered by NJ's student rep to State BOE

"Many students in schools across New Jersey have heard Parkland's call to action and for change," says Karan Chauhan, student representative to the New Jersey State Board of Education. While speaking at the April 4 New Jersey State Board of Education meeting in Trenton, Chauhan noted that "students have the right to live and to go to the movie theater, concerts, or even to a Board of Education meeting with a sense of security."

In addressing the growing number of student rallies, walkouts, letters to the editor and other activities, Chauhan shared with the Board that "students are strengthening their voices in society and are becoming civically engaged, something that should be considered a critical part in one's education." Chauhan believes that as students "develop professional and practical skills, we must also develop civic engagement within

He asked that the New Jersey State Board of Education support these student efforts by taking a leadership role and providing schools with resources to properly support students in their engagement.

Chauhan concluded by referencing "Student Voice, Student Advocacy", an initiative by the New Jersey Association of Student Councils (<u>www.njasc.org</u>) to provide support and reliable resources for all New Jersey students to help them become engaged while also promoting voter registration among eligible students. "We must support our student voices today, as they will the most important voices in the years to come."
